# President's Message

Dear CBA Members:

Happy Fall! I hope this letter finds you and your family safe and healthy and, that you've had a chance to enjoy the spectacular weather we've been having.

We had an amazing time at our golf social held at the C.C. in September. Besides a lot of laughs we raised \$2,500.00 that will benefit our high school scholarship fund. Please note this scholarship is available to any H.S. senior, even if they are attending high school out of town (candidates can apply for the scholarship on our website).

Thanks to all of the golfers, sponsors, volunteers and the golf committee for making this event such a great success! We had a full field with 11 foursomes. The weather was fabulous, except for puddling on some of the fairways due to the torrential rain from the night before. The rain did, however, create some fishing opportunities for some of the golfers!

Congratulations to WNA for taking the top honors with a low gross score of 58; Lowell Five finished with a low net score of 50; Mickey Lyons & Mary Moriarty won the longest drive contest; and, Rob Ayles & Mary Moriarty won the closest-to-pin contest. Getting back to business, we are all feeling the hangover from the COVID shutdown, as well as, the generous spending policies from the White House. I mentioned in my Summer letter to expect the "I" word

to return. Well, it's here and in a big way. The most obvious price jump is at the pumps. My monthly gas bill is up by over \$100--thank you Mr. Biden. Perhaps shutting down the Keystone Pipeline wasn't such a good idea after all? Just saying...

Inflation is going to get worse, not just because of supply-chain disruptions and Washington spending, but also because of the historically low job-participation rate. Let's face it, anyone who wants a job can have one. Moreover, upward pressure on wages is happening without a National increase to the minimum wage. Go figure, the Classical Economic "Invisible Hand" at work again...

The other headline that keeps me up at night is the supply-chain chaos. Folks, keeping the ports open around the clock isn't going to fix the problem. Even if we cleared the ports tomorrow, we need a place to put thousands of containers. More importantly, how do we ship these goods without enough truck drivers? We plan to ask the Select Board for relief and continued movement toward parity. Please show your support by attending and voicing your concerns to the Select Board over the current 1.22X split rate. This is simply bad math given the high ratio of residential-to-commercial units in our town.

Our Annual Meeting, to be held at the CBA office, is scheduled for November 18th. Please contact our office if you are interested in attending. All are welcome. Also, mark your calendars for our Holiday Social to be held at the Princeton Station on Thursday, December 9th. As a reminder your annual membership includes two tickets for dinner and entrance in the door-prize raffle. John Mansfield will once again be providing the entertainment. This is always a fun event to catch up with fellow members, dance and enjoy some great food. Tickets can be purchased for additional guests as well.

Lastly, as I've said before, I encourage you all to become active in the association. We are always looking for fresh ideas and ways to improve and grow the association. We also want to know what concerns you might have with doing business in town. We are here to act as your voice on issues impacting the Chelmsford business community. 



# ARTICLE V NOMINATION AND ELECTION OF DIRECTORS AND OFFICERS

**Section 1:** The Directors and Officers for the ensuing year commencing January 1st; shall be elected by the entire membership according to the rules specified in sub-paragraphs (a through f) of this section under the direction of the current Nominating Committee.

**(a)** The election shall take place on a date to be determined by the Board of Directors in the month of November.

**(b)** Nominations shall be made by a Nominating Committee designated by the President consisting of five (5) members, not more than three of whom may be a current member of the Board of Directors.

**(c)** The Nominating Committee shall place on the ballot sufficient names to fill

all officer positions and sufficient to fill all open director positions. In addition, any member may be nominated by petition of ten (10) members and with his/her assent be placed upon the ballot by the Nominating Committee. Said petition must be submitted to the Association's Secretary not less than twenty-one (21) calendar days prior to election.

**(d)** A notice with the names of those nominated appearing thereon, in alphabetical order according to their surname, shall be mailed to all Association members in good standing not more than fifteen (15) days not later than ten (10) days before the election. Those names receiving the highest number of votes at the annual meeting shall be declared elected. Election at the

annual meeting may be in such manner as the Board of Directors dictates.

**(e)** In the case of a tie for any office, the one to serve shall be determined by lot at the annual meeting by the President.

**(f)** Nominations received after the time designated in subsection (c) above shall be void.

**Section 2:** Within ten (10) days after the annual election, the Directors for the ensuing fiscal year shall meet and establish its committees for the ensuing year.

**Section 3:** Vacancies for unexpired terms on the Board of Directors may be filled by the membership for the unexpired term at the next meeting of the membership.
