The real estate tax rate and how it will be split between residential and commercial property owners will be discussed at the November 7th Select Board meeting. A detailed analysis will be presented by Frank Reen, the town's Chief Assessor. The Select Board will then vote on the rate split on November 21st. The current split is 1.20X, meaning commercial property owners pay 20% more of the tax levy than residential property owners. Inflation, especially gasoline prices, increasing interest rates and the continued labor shortage are wreaking havoc on the Chelmsford business community. Higher taxes are simply the wrong direction to take. As your voice, we will ask the Select Board for relief and continued movement toward parity. More than ever, we need as many business owners as possible to attend this meeting and voice their concern to the Select Board. Please make every effort to attend this very important meeting. Even if you do not plan to make a statement, your presence will make a difference.

Our Annual Meeting will be held at the CBA office on Thursday, November 10th at 7:00. Please contact our office if you are interested in attending. All members are welcome. 
This is always a fun event to catch up with fellow members, dance and enjoy some great food. Tickets can be purchased for additional guests as well.

### THE NATIONAL SEPTEMBER 11 MEMORIAL & MUSEUM

### INTERGENERATIONAL ACTIVITIES

### BEETS

Beets deserve a badge of honor in the veggie family, says Jorge A. Brenes-Salazar, MD, a geriatric cardiologist and assistant professor of medicine at the Mayo Clinic. That's due to their high doses of nitrates, which help keep blood vessels dilated and healthy. A 2013 British study showed that simply drinking a cup of beet juice daily significantly lowered blood pressure in hypertensive patients. (AARP, January 27, 2021)

## ARTICLE V NOMINATION AND ELECTION OF DIRECTORS AND OFFICERS

**Section 1:** The Directors and Officers for the ensuing year commencing January 1st; shall be elected by the entire membership according to the rules specified in sub-paragraphs (a through f) of this section under the direction of the current Nominating Committee.

**(a)** The election shall take place on a date to be determined by the Board of Directors in the month of November.

**(b)** Nominations shall be made by a Nominating Committee designated by the President consisting of five (5) members, not more than three of whom may be a current member of the Board of Directors.

**(c)** The Nominating Committee shall place on the ballot sufficient names to fill all officer positions and sufficient

to fill all open director positions. In addition, any member may be nominated by petition of ten (10) members and with his/her assent be placed upon the ballot by the Nominating Committee. Said petition must be submitted to the Association's Secretary not less than twenty-one (21) calendar days prior to election.

**(d)** A notice with the names of those nominated appearing thereon, in alphabetical order according to their surname, shall be mailed to all Association members in good standing not more than fifteen (15) days not later than ten (10) days before the election. Those names receiving the highest number of votes at the annual meeting shall be declared elected. Election at the annual meeting may

be in such manner as the Board of Directors dictates.

**(e)** In the case of a tie for any office, the one to serve shall be determined by lot at the annual meeting by the President.

**(f)** Nominations received after the time designated in subsection (c) above shall be void.

**Section 2:** Within ten (10) days after the annual election, the Directors for the ensuing fiscal year shall meet and establish its committees for the ensuing year.

**Section 3:** Vacancies for unexpired terms on the Board of Directors may be filled by the membership for the unexpired term at the next meeting of the membership.




